[origin: US2017095083A1] A device for releasably connecting a furniture pull-out to a guidance unit that movably guides the pull-out in a furniture body comprises: a base part; and an adjuster arranged on the base part and comprising a plurality of components movable in relation to one another, the adjuster enabling a position of the furniture pull-out to be set in at least one spatial direction relative to the guidance unit, the adjuster including a spring-loaded contact pressure mechanism configured to press the guidance unit against the device in a fitted and working condition.
