Abstract (en)

The present invention relates to an anchoring plate (1) for a closure device for a sports footwear and to a closure device (21) for a sports footwear incorporating such anchoring plate. According to the invention, the anchoring plate (1) comprises - in addition to a body (3) provided with hooking seats (7) for the hooking means (29) of the tensioning member (27) of a closure device (21) - an extendable member (9) which is movably connected to said body and is provided with at least one additional hooking seat (15). In this way, a closure device (21) incorporating an anchoring plate according to the invention can move from a configuration in which the user's foot is firmly held inside the sports footwear to a configuration in which the user's foot has a certain freedom of movement inside the footwear, and in either of said configurations the elements of the closure device are retained in some way, so as not to be of hindrance to the user.
