Abstract (en)

The present invention relates to a shoe upper (11) for a shoe, in particular for a sports shoe, comprising a rear section (14) and a front section (15), wherein the front section (15) is smaller graded than the rear section (14), and wherein the front section (15) is more flexible than the rear section (14).
