Abstract (en)  
Support element adapted to connect a drying system (10) of a household appliance (1) configured to perform at least a drying cycle to a tub (3) of said household appliance (1), said support element (100) being made of a thermally insulating material, wherein said support element (100) comprises: a base portion (110) adapted to be fitted on said tub (3); a constraint portion (120) adapted to grasp an engaging portion (55) of said drying system (10). The constraint portion (120) comprises: an upper part (121); a lower part (122); said upper part (121) and lower part (122) being mutually spaced apart to form a housing (130) for said engaging portion (55); said constraint portion (120) further comprising a connection part (123) connecting said upper part (121) and lower part (122), said upper part (121), lower part (122) and connection part (123) being made in one piece. A household appliance adapted to perform at least a drying cycle, comprising one or more of said support elements, is also disclosed.
