[origin: US2017075548A1] There is provided a display control device, an information processing device, an information processing method, and a program capable of presenting information in a suitable mode according to a positional relationship between a display region and a user, the display control device including: a calculation unit configured to specify a first region in which a user is a reference point; and a display control unit configured to control display of a display object on a display unit according to the specified first region and a second region occupied by the display unit.
