Abstract (en)

[origin: WO2016001572A1] The invention relates to an arrangement for the spectrometric measurement of products such as cereals, oleaginous products or derived products. According to the invention, the arrangement is characterised in that it comprises a mechanism (17, 18, 19) for the selective adjustment of the position of the light beam in the vertical and horizontal planes, and a selective adjustment device for ensuring the parallelism of the rays of the light beam. The invention is especially applicable to the area of cereals.
