[origin: WO2013037924A1] Sports boot comprising: an inner boot (3); an exogeneous shell (1), the dimensions of which allow said inner boot (3) to be inserted into or extracted from it, said exogeneous shell strengthening said inner boot and allowing it to be attached to a piece of sports equipment; characterized in that: said exogeneous shell comprises a sole (10), a forward part of an upper (11) able to pivot with respect to said sole (10) about a first articulation (110), and a rear part of an upper (12) which is able to pivot with respect to said sole (10) about a second articulation (120).
