[origin: WO2016005736A1] A method of manufacturing a security device (10) for a security document. The method comprising: providing a substrate (20) having a face (30), the face including a plurality of first walls (50), each first wall (50) being orientated in a first direction and a plurality of second walls (60), each second wall (60) being orientated in a second, different direction; and directing a flow of particles to form a layer of material (70) on one of either (i) each of the plurality of first walls (50) or (ii) each of the plurality of second walls (60).
