Abstract (en)

A downhole packer assembly that includes an inner packer and a drain (50) coupled to the inner packer. The drain includes a sample inlet (96), a guard inlet (98), and a seal (40) disposed between the sample inlet and the guard inlet. The seal is configured to move into a space between the sample inlet and the guard inlet based on hydrostatic pressure.
