[origin: CN107023588A] In particular, the present invention relates to a wear compensating double clutch (1) which is particularly useful for motor vehicles. The clutch includes at least a reaction disc (4), the first and second friction discs (5a, 5b), first and second platens (3a, 3b) respectively actuated by the first and second diaphragms (9a, 9b), a fixed cover (6), a first wear detection and compensation device mounted between the first diaphragm (9a) and the fixed cover (6), and a first wear detection and compensation device mounted on the second diaphragm (9b) and the second pressure Disc (3b) between the second wear detection and compensation device.

L'invention concerne notamment un double embrayage (1) à rattrapage d'usure, notamment pour véhicule automobile, comportant au moins un plateau de réaction (4), un premier et un second disques de friction (5a, 5b), un premier et un second plateau de pression (3a, 3b) actionnés respectivement par un premier et un second diaphragme (9a, 9b), un couvercle fixe (6), des premiers moyens de détection et de rattrapage d'usure montés entre le premier diaphragme (9a) et le couvercle fixe (6), et des seconds moyens de détection et de rattrapage d'usure montés entre le second diaphragme (9b) et le second plateau de pression (3b).
