Abstract (en)

[origin: WO2016015934A1] The invention relates to a ball joint (1) comprising a ball journal (3) and a housing (2), the ball journal (3) together with the ball being rotationally and pivotally movably accommodated in the housing (2), and the ball (3a) being at least partly surrounded by a structural component (4). Said structural component (4) essentially consists of a fiber-plastic composite structure and forms at least part of the housing (2).
