[origin: WO2016020021A1] Transaction management method by recognition of the registration number of a vehicle(2), said method comprising: - a step for pre-registration by a client (1) of data relating to personal identification, payments and identification of at least one vehicle (2); - a step for reading the registration number of a vehicle (2); - a step for transmission of the registration number of the vehicle (2) to a data platform (5); - a step for identification of the vehicle (2) by the data platform (5); - a client (1) authentication step by entry of a personal identification number; - a step for proposing the transaction to the authenticated client (1); - a step for pre-authorization of the transaction by the client (1); - a transaction authorization step by a transaction authorization server (6); - a step informing the client (1) of the transaction authorization.
