Abstract (en)

A package of tobacco articles, having: a group (4) of tobacco articles; a sealed inner package (3) enclosing the group (4) of tobacco articles having an extraction opening (5) from which to extract the tobacco articles being closed by a sealing flap (6); and a stiffener (8) located inside the sealed inner package (3) contacting the group (4) of tobacco articles which has a front wall (9), two lateral walls (10) located on opposite sides of the front wall (9) and a bottom wall (11) contacting the tips of the tobacco articles; the stiffener (8) also having a connecting system for connecting the bottom wall (11) to the lateral walls (10) of the stiffener (8) including a bottom tab comprising an appendix (15), to prevent movement of the two lateral walls (10) with respect to the bottom wall (11).
