[origin: WO2015086823A2] The invention relates to a fertilizer mixture containing A. lime ammonium nitrate mineral fertilizer which can contain up to 15 wt%, relative to the lime ammonium nitrate mineral fertilizer without water, of ingredients other than ammonium nitrate and calcium carbonate and/or magnesium carbonate and, optionally, water, B. 100 to 10,000 ppm, relative to component A without water, of 2-(N-3,4-dimethylpyrazole)succinic acid.
