Abstract (en)

[origin: WO2016058749A1] The invention relates to a method for the permanent shaping and color modification of keratin fibers, particularly human hair, in a single process, in which first a waving of the keratin fibers is carried out by means of a perming agent (M1) and subsequently an oxidative dyeing by means of a dyeing agent (M2). In a subsequent step and in order to fix the hair perming, a fixative (M3) is applied. The process according to the invention results in an uniform perming and dyeing result and leads only to small or no damage to the hair.
