Abstract (en)

[origin: WO2016066279A1] The invention relates to a device for further processing web- or sheet-type printing material (002') having a further processing section (003) in which printing material (002') supplied or to be supplied on the input side can be processed into printed products (P(Z); P(T); P(B); P(S)), wherein, in the guide path of a processing segment to be passed through by the printing material (002'), the further processing section (003) comprises at least one transverse folding device (602) and a collection device (611), arranged after the printing material path, as further processing stages (602; 611), by means of which two or more intermediate products (616) folded in a transverse direction upstream by means of the transverse folding device (602) can be combined on top of one another to form a bundle (618). The collection device (611) arranged after the transverse folding device (602) comprises a rotatable body (646), on the periphery of which the two or more transversely folded intermediate products (616) can be combined on top of one another to form a bundle (618), as well as retaining means (648) for retaining intermediate products (616) to be collected on the periphery of the rotatable body (646). The invention also relates to a corresponding production line, and a corresponding method for the production of printed products.
