Abstract (en)

[origin: WO2016080892A1] A food-waste tank (1) comprising at least two chambers (7, 8) located one after the other separated by a separating wall (6) and comprising a first inlet (9) for food waste mixed with water and a second inlet (10) principally for dish-washing water without food waste. The food-waste tank (1) is formed by an extended double-walled pipe (12) with an end wall (2, 3) at each end that seals the tank (1) and an internal separating wall (6) that extends essentially over the complete diameter of the tank (1), and that divides the food- waste tank into two chambers (7, 8), one of which follows the other. It is preferable that the double-walled pipe (12) is formed by an element of duct, preferably square, wound as a screw, and that connections are arranged to the interior of the element of duct in order to lead a heat-exchange fluid into and out from the interior of the element of duct.
