Abstract (en)
The invention relates to a waste storage device (1), comprising a container (2, 3) with a container opening (8) and a driver ring (12), which is rotatably mounted to the container (2, 3) in the region of the container opening (8). The driver ring (12) is also designed to catch a waste storage bag or waste storage hose (13) guided through a center opening of the driver ring (12). The waste storage device (1) also comprises a gear rod (25), which is movably guided in the container (2, 3) at its first end, which is coupled to the driver ring (17) and which faces the lid (9) respectively cooperates with the lid (9) on its free second end. Furthermore, the invention relates to a waste storage system (20), comprising a waste storage device (1) of said kind and a storage cassette (17) containing the waste storage bag or waste storage hose (13).
