[origin: US2017133126A1] A cable, in particular a data cable, which extends in a longitudinal direction, includes a central element which is surrounded, in particular encased, by a ribbon lead element. The ribbon lead element has two film layers as well as a plurality of leads, in particular conductor elements, which are disposed between the film layers. A method for manufacturing a cable, a ribbon lead element, a method for manufacturing a ribbon lead element and a motor vehicle using the cable are also provided.
