Abstract (en)

[origin: WO2016102246A1] The present invention relates to a molded body made of an expanded particle foam material, at least one fiber (F) being located partly within the molded body, i.e. being surrounded by the expanded particle foam material. The two ends of the respective fiber (F) which are not surrounded by the expanded particle foam material thus protrude on one side of the corresponding molded body. The invention also relates to a panel which comprises at least one such molded body and at least one additional layer (S1). The invention further relates to methods for the production of the molded bodies from expanded particle foam material or of the panels according to the invention and to the use thereof, for example as rotor blades in wind turbines.
