Abstract (en)

[origin: EP3239328A1] The present invention relates to a steel sheet for low-temperature service, which can be used at a wide temperature range from low temperature to room temperature in liquefied gas storage tanks and transport facilities, and provides: a steel sheet for low-temperature service having an excellent surface processing quality even after a processing processes is performed, such as a tension process; and a method for manufacturing the same. An aspect of the present invention relates to a steel sheet for low-temperature service having an excellent surface processing quality, the steel sheet for low-temperature service containing manganese (Mn, 15-35 wt%), carbon (C, satisfying $23.6C + Mn \leq 28$ and $33.5C - Mn \leq 23$), copper (Cu, 5 wt% or less (excluding 0 wt%)), chrome (Cr, satisfying $28.5C + 4.4Cr \leq 57$ (excluding 0 wt%)), titanium (Ti, 0.01-0.5 wt%), nitrogen (N, 0.003-0.2 wt%), the balance iron (Fe), and other inevitable impurities, wherein Ti and N satisfy relational expression 1 below. [Relational expression 1] $1.0 \leq Ti/N \leq 4.5$ (provided that, Mn, C, Cr, Ti, and N in the respective expressions mean wt% of respective ingredient contents).
