[origin: EP3246075A1] A ball supply apparatus includes: a housing coupled to the upper portion of the column structure, wherein a top portion of housing is partially opened, wherein the housing is divided by a partition into a ball storage portion and a ball discharge portion, wherein a bottom face of the ball storage portion is inclined downward toward the ball discharge portion, wherein a first opening is formed in a bottom of the ball discharge portion, and a second opening is formed in the partition at a lower portion thereof; a rotatable opening/closing plate rotatably coupled to the partition, wherein the rotatable opening/closing plate is configured to rotate to open/close the second opening; and a ball discharge tube rotatably coupled to the ball discharge portion at the first opening, wherein the ball discharge tube ball-communicates with the ball discharge portion via the first opening.
