Abstract (en)

An introducer is involved, to be applied on machines for primary processing operations of pressing, embossing, staking and finishing, on leather, tanned leather, fabric, synthetic material and others. Said introducer (100) comprises a first device (10), serving the function of introducer/crease spreader, formed by the pair of webs wound in a ring (1, 2), to which a second device (20) is connected immediately upstream, serving the function of transfer belt, on which the operator deposits the product (P), and of providing for, inside each of the two webs (1, 2), thermal apparatuses (3, 4) which transmit the heat to the two portions of the above webs and which define the channel for the passage of the product (P) which, consequently, undergoes heating on both sides, thus obtaining a pre-heating of the product itself.
