Abstract (en)

[origin: WO2016137300A1] An electronic device, an electronic payment function, and an operation method are provided. The electronic device includes a display, a communication interface, and a processor, wherein the processor is configured to transmit a user identifier to a server through the communication interface, receive information of at least one card associated with the user identifier from the server through the communication interface and display the received information on a display, select one piece of card information from the displayed information of the at least one card, and request, through the communication interface, the server to issue a token for payment, using at least a part of the selected card information.
