Abstract (en)

A welding process of an inflatable product is provided that includes using isolating members (6) between first and second portions of weldable tensioning members (4) to resist the first and second portions of the weldable tensioning structures being welded together during welding of the first portions to a first sheet (5) of weldable material and welding of the second portions to a second sheet (7) of weldable material.
