Abstract (en)
The invention describes a modular structure (10) for supporting and transporting at least one object (A). The structure (10) comprises a plurality of support feet (12), provided on top with connection means (16) for the reversible connection with the object (A), and at least one support bar (18), constrainable below one or more support feet (12) and configured for resting on the ground or on a generic surface, as well as for supporting the structure (10) and therefore the object (A). The structure (10) reduces the spaces occupied with respect to conventional pallets as well as ensuring, with an extremely low number of base components able to be variously and reversibly connected to one another, the same functionality as a wide range of conventional pallets that are different from one another.
