[origin: WO2016155902A1] The invention relates to a cosmetic product for temporary shaping keratin fibres, in particular human hair, containing a combination of a copolymer A based on acrylates with a cross-linked polyurethane-vinyl-copolymer B. Said cosmetic product has a good level of moisture resistance. The invention also relates to the use of said cosmetic product and to a method for temporary shaping keratin fibres using said product.
