[origin: GB2536905A] A radiant burner 10 for treating an effluent gas stream from a manufacturing processing tool comprising plural treatment chambers 90, each treatment chamber having an inlet 30 for supplying a respective portion of said effluent gas stream to that treatment chamber. The treatment chambers are preferably arranged in a matrix comprising plural rows of plural treatment chambers with a separating structure 50B comprising a porous screen between adjacent treatment chambers. The separating structure preferably tapering in a direction of flow
