Abstract (en)

[origin: WO2016171864A1] A device includes one or more processor, a display, and a module card. The one or more processor determines that a communication function of the device has terminated and sends a notification to the module card that indicates the termination. The module card sends a message to a server in response to receiving the notification and receives another message from the server. The message indicates that the device is ready to receive the other message. The other message includes an instruction and another notification, which is based on usage of an account and identifies an actionable category with respect thereto. The instruction causes the one or more processor to function as display, receiving, determining, and sending devices, which respectively display the other notification, receive an input response thereto, determine that the response corresponds to a confirmation to implement the actionable category, and send a further message including the response.
