Abstract (en)

A golf ball 2 includes a core 4, an inner cover 8, a mid cover 10, and an outer cover 12. Nine points are determined by dividing a region from a central point of the core 4 to a surface of the core 4 at intervals of 12.5% of a radius of the core 4. When distances (%) from the central point to the nine points and hardnesses at the nine points are plotted in a graph, R 2 of a linear approximation curve obtained by a least-square method is equal to or greater than 0.95. A hardness H_i of the inner cover 8 is greater than a hardness H_s at the surface of the core 4. A hardness H_o of the outer cover 12 is greater than the hardness H_i . A difference ($H_o - H_i$) is 1 or greater. A difference ($H_o - H_s$) is 5 or greater but 30 or less.
