Abstract (en)

The invention relates to an apparatus for performing bodyweight exercises, such as dips and pull ups, comprising a straight guide (10) fixed vertically on a vertical wall (2), a first slider (20) sliding on the straight guide and lockable in different positions by means of a locking mechanism acting on the straight guide, an U-shaped equipment (30) comprising two substantially parallel arms joined together at one end with a connecting element; the equipment is mounted via the connecting element to the first slider. The U-shaped equipment (30) is rotatable relative to the first cursor (20) between a working position where the two arms are located on a horizontal plane and a resting position where the two arms are located on a vertical plane parallel to the vertical wall (2) and further the equipment stops in the two abovementioned positions. The object of the present invention is to provide a complete exerciser apparatus resealable, compact in size, not cumbersome and economic.
