Abstract (en)

[origin: WO2017167357A1] The invention relates to an apparatus for packaging piece goods batches (10), having a transport device (3) which transports a plurality of piece goods (1) in a predefined transport direction (T), having a first wrapping device (2) which is suitable and intended to wrap a film element (12) around the piece goods, wherein said first wrapping device (2) has a dispensing unit (30) having a dispensing element running around the piece goods, wherein the piece goods (1) can be fed to the first wrapping device (2) in order to be wrapped with the film element (12). According to the invention, the apparatus (50) has a further wrapping device (4) which is suitable and intended to wrap the piece goods with a film element, wherein said further wrapping device (4) has a dispensing unit (30) having a dispensing element running around the piece goods, wherein the piece goods (1) can be fed to the first wrapping device (2) in order to be wrapped with the film element and wherein, during working operation of the apparatus, the first wrapping device (2) and the further wrapping device (4) can be used optionally in order to wrap the piece goods (10).
