Abstract (en)

A folding scaffold (1) comprises two pairs of side uprights (2, 3) and a pair of central uprights (4), a pair of platforms (5, 6), a double pair of crossbeams (7, 8), a double pair of telescopic diagonal rods (9, 10) hinged between each pair of side uprights (2, 3) and the pair of central uprights (4) for clamping and stabilizing the platforms (5, 6) and the uprights (2, 3, 4). The double pair of crossbeams (7, 8) is hinged in the vicinity of the upper ends of the central uprights (4), and the platforms (5, 6) are hinged to the two pairs of side uprights (2, 3) and the pair of central uprights (4), in a manner that the side uprights (2, 3) are maintained parallel to the central uprights (4) in folding the scaffold (1).
