[origin: US2018087761A1] The invention relates to a light emission system that includes a light source support having a first cooperation member, a printed circuit board fixed to the light source support and a connection system, a connection cable including a connection plug. The connection plug has a second cooperation member. The connection system, the support and the plug are arranged in such a way that when the connection system and the plug are connected to one another, the first and the second cooperation members cooperate together to form a fixed mechanical link.

L'invention concerne un système d'émission de lumière (1) comprend : - un support (2) de source lumineuse comprenant un premier organe de coopération (213), - un circuit imprimé (3) fixé au support (2) de source lumineuse et comprenant un système de connexion (5), - un câble de connexion (7) comprenant une prise de connexion (6), cette prise de connexion (6) comprenant un deuxième organe de coopération (62), Selon l'invention, le système de connexion (5), le support (2) et la prise (6) sont agencés de manière à ce que lorsque le système de connexion (5) et la prise (6) sont branchés l'un à l'autre, le premier (213) et le deuxième (62) organes de coopération coopèrent ensemble pour former une liaison mécanique fixe.
