[origin: WO2017004629A1] The invention relates to a chair for chairlifts, which has a restraining bar (7) that can be pivoted about an axis (10) into a closed and into an open position, a locking element (4) on the restraining bar (7) and a blocking element (11) for the locking element (4). The blocking element (11) can be moved into a locking position and into a released position by an actuating element (5) that can be pivoted about the axis (10).
