[origin: WO2017013158A1] The invention relates to automatic dishwasher detergents containing at least one bleaching agent, at least one bleach catalyst, at least one homopolymer of α,β ethylenically-unsaturated carboxylic acids and at least one copolymer containing at least one monomer containing sulphonic acid groups, and at least one monomer from the group of the α,β ethylenically-unsaturated carboxylic acids, as well as to the use of same in a machine dishwashing method, and to a corresponding method for machine dishwashing.
