Abstract (en)

The present invention provides a lubricating composition for use in the crankcase of an engine comprising (i) a base oil; (ii) one or more oil-soluble molybdenum compounds in an amount sufficient to provide in the range of from 100 to 1000ppm of molybdenum; and (iii) one or more alkyl dithiocarbamate compounds.
