[origin: US2018173162A1] Dial assembly for a timepiece, comprising a base plate on which feet are fixed, and supporting a three-dimensional decoration which comprises at least one offset element at a remove from the base plate and fixed to the base plate through at least one foot, and which comprises at least one bush provided to be pressed in on an upper support abutting on a shoulder which this foot comprises, the dial assembly comprising a removable fitting which is used for pressing in all the bushes which the dial assembly comprises, and comprising, opposite a lower support which each foot comprises, a support pin of this lower support.

Ensemble cadran (10) pour pièce d'horlogerie, comportant une plaque de base (1) sur laquelle sont fixés des pieds (4), et supportant un décor tridimensionnel lequel comporte au moins un élément déporté (7) distant de la plaque de base (1) et fixé à la plaque de base (1) au travers d'au moins un pied (4), et lequel comporte au moins un canon (6) agencé pour être chassé sur une portée supérieure (46) en appui sur un épaulement (47) que comporte ce pied (4), l'ensemble cadran (10) comportant un posage amovible (20) utilisé pour le chassage de tous les canons (6) que comporte l'ensemble cadran (10) et comportant, face à un appui inférieur (49) que comporte chaque pied (4), un plot d'appui (29) de cet appui inférieur (49).
