[origin: WO2017135939A1] One example provides a method. The method includes etching a portion of a substrate to create a plurality of cavities, the substrate including a metal-containing material. The method includes disposing a resin over the portion, including filling at least some of the plurality of cavities with the resin. The method includes anodizing the substrate, including the portion. The method includes disposing a hydrocarbon lubricant over the anodized substrate.
