[origin: EP3375613A2] The invention provides an inkjet print apparatus (100) and a recovery method of an inkjet print apparatus (100), which can suppress deterioration of productivity. For that purpose, timing, at which a recovery operation is practiced in accordance with a facing time period of a print head and a print medium (P) and a not facing time period thereof, is set.
