[origin: EP3375855A1] The present invention relates to the use of liquid fabric softener compositions as well as the methods of treating synthetic fabric. Such liquid fabric softener compositions comprise cellulose fibers and encapsulated benefit agent. The use of cellulose fibers in such fabric softener compositions improves the deposition of encapsulated benefit agent.
