Abstract (en)  
[origin: WO2017093463A1] The present invention relates to a compatible solute or solute mixture and to a composition containing at least one solute or a solute mixture for use in the prevention or treatment of barrier defects in epithelial tissues associated with at least one bio-based noxa, in particular of diseases comprising at least one barrier defect in at least one cell layer of at least one epithelial tissue, wherein at least one solute is selected from compounds of formula I, formula II, the physiologically acceptable salts of formula I and formula II, the stereoisomeric forms of compounds of formula I, formula II and the physiologically acceptable salts of the stereoisomeric forms or a mixture of at least two of the aforementioned compounds. The at least one compatible solute, solute mixture and/or the composition are provided in the form of a cosmetic, medical device, pharmaceutical product, an addition to any of the aforementioned articles of manufacture or as a constituent of an in-vitro diagnostic product (IVD).
