[origin: WO2017098008A1] The invention relates to a method for slicing a bar of food into nominal food slices and/or for portioning nominal food slices, having a cutting device, which has a cutting knife, by means of which the nominal food slices are separated from the bar of food, wherein the bar of food is transported in the direction of the cutting knife at a nominal feeding velocity during slicing of the nominal food slices, wherein, before the separation of the first nominal food slice, at least one trimming food slice is separated from the front end of the bar of food.
