Abstract (en)

The present disclosure pertains to the technical field of medicine, and particularly relates to a compound for treating open injury, and a preparation method and an application thereof. The compound for treating open injury is prepared from the following raw materials: a guanidine disinfectant and/or a quaternary ammonium disinfectant, and a water-soluble anionic cellulose and a derivative thereof. The compound for treating open injury of the present invention may reduce the time of exposing a wound to be minimum in various emergency situations, to reduce the number of bacteria and bacterial endotoxins to a maximum extent. The compound for treating open injury of the present invention is convenient to store, carry and use, is dedicated in the treatment field of open injury, and has a wide application prospect.
