[origin: WO2017129670A1] The present invention relates to a composition, in particular a cosmetic or dermatological composition, comprising, in a physiologically acceptable medium: a) at least one merocyanine of formula (1) or (2) b) at least one oily phase comprising at least one N-substituted amide of formula (4): The present invention also relates to a non-therapeutic cosmetic process for caring for and/or making up a keratin material, comprising the application, to the surface of said keratin material, of at least one composition as defined above. The invention also relates to a non-therapeutic cosmetic process for limiting the darkening of the skin and/or improving the colour and/or uniformity of the complexion, comprising the application, to the surface of the keratin material, of at least one composition as defined previously. The present invention also relates to a non-therapeutic cosmetic process for preventing and/or treating the signs of ageing of a keratin material, comprising the application, to the surface of the keratin material, of at least one composition as defined previously.
