Abstract (en)  
[origin: EP3409828A1] An iron is described. The iron comprises a soleplate, a heating element thermally coupled with the soleplate and a thermostat unit configured for controlling operation of the heating element, the thermostat unit being configured for alternately effecting heating phases and non-heating phases of the heating element. The iron further comprises a switch element adapted for switching a power supply of the heating element and a control unit adapted for controlling a switching operation of the switch element. The control unit is configured for assigning a respective time pattern defining one or more power interruption intervals to at least one selected heating phase of said heating phases, with the switch element being configured for interrupting power supply of the heating element during the one or more power interruption intervals in accordance with the respective time pattern.
