Abstract (en)

[origin: CN208925312U] To make up for defects in the prior art, the efficiency of a known device in the prior art is improved; the utility model relates to a detachable fixing device for a walking stick, wherein the shell is provided with an insertion part and a containing part; one of the two parts is used for being fixed to a handle of the walking stick, the other one of the two parts is used for receiving a spike; the connector is characterized in that the insertion part is provided with at least one connecting surface which is suitable for being elastically embedded and matched with at least one connecting surface of the containing part, one of the insertion part or the connecting surface of the containing part is provided with some wedges, the containing part or the other connecting surface of the insertion part is provided with some orifices, and the orifices are suitable for being matched with the wedges. The utility model also relates to a handle for a walking stick, a walking stick, a kit for a walking stick, and a detachable glove for a walking stick.

Dispositif de fixation (1) amovible pour bâton (2) comprenant une partie mâle (100) et une partie femelle (200), l'une de ces deux parties (100, 200) étant destinée à être fixée à une poignée (3) d'un bâton (2) et l'autre de ces deux parties (100, 200) étant destinée à recevoir une dragonne (4), caractérisé en ce que la partie mâle (100) comprend au moins une surface de liaison (110) apte à coopérer par emboîtement élastique avec au moins une surface de liaison (210) de la partie femelle (200), l'une des surfaces de liaison (110 ; 210) de la partie mâle ou femelle comprenant des picots (130) et l'autre surface de liaison (210 ; 110) de la partie femelle ou mâle comprenant des ouvertures (230) aptes à coopérer avec lesdits picots (130).
