Abstract (en)

A water composition (9) is adapted to be received and sealed in a container (81) and includes water (91) that is capable of being utilized by living organism, silicic acid and hydrogen gas (92) dissolved in the water (91). The silicic acid of the water composition (9) is present in an amount of not greater than a saturation concentration of the silicic acid. The water composition (9) has an oxidation reduction potential (ORP) that is lower than -400 mV. A filter (42) for producing the water composition (9) includes a carrier (421) and a silicon material (422) adsorbed on the carrier (421). A filter (4) assembly and a water purification system containing the filter (42) are also provided.
