[origin: WO2017140724A1] A device (1, 1') for applying adhesive and/or sealant having a housing (2) for receiving a container (16), said housing (2) having the following: - a receiving chamber (15) for receiving the container (16); - a closable application tip (17) which is connected to the receiving chamber (15) and through which the adhesive and/or sealant can be discharged; - a stable casing (4) for the receiving chamber (15); - at least one region of the housing (2) which is in the form of a deformable pressure region (5) and which allows pressure to be exerted from the outside onto the container (16) which can be placed in the receiving chamber (15).
