Abstract (en)

[origin: WO2017167426A1] The invention relates to a method for packing arrangements of piece goods (1), in which a plurality of piece goods (10) and particularly containers (10) are at least partially interconnected by means of a first connection means, at least two piece goods of said plurality of piece goods being directly interconnected by means of the connection means (42). According to the invention, this plurality of piece goods (10) connected by means of the connection means (42) is packed with a second connection means in the form of a second wrapping element (14) and the plurality of piece goods connected by means of a first connection means is transported to a packaging device (54) by means of a transport device and surrounded and particularly wrapped by means of said packaging device (54) with the second wrapping element (14).
